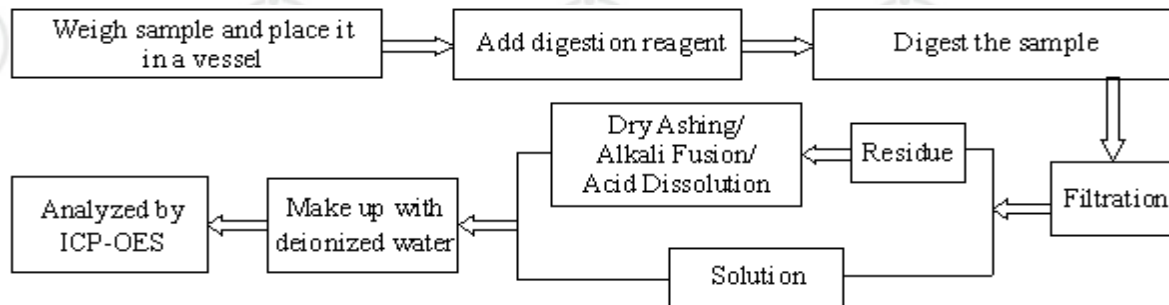

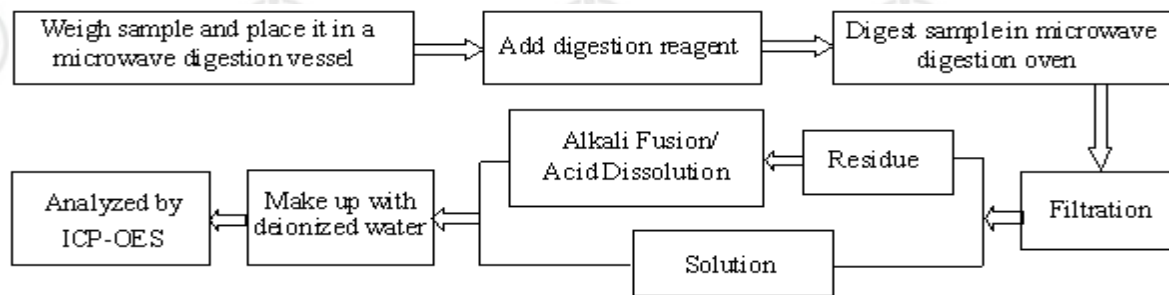

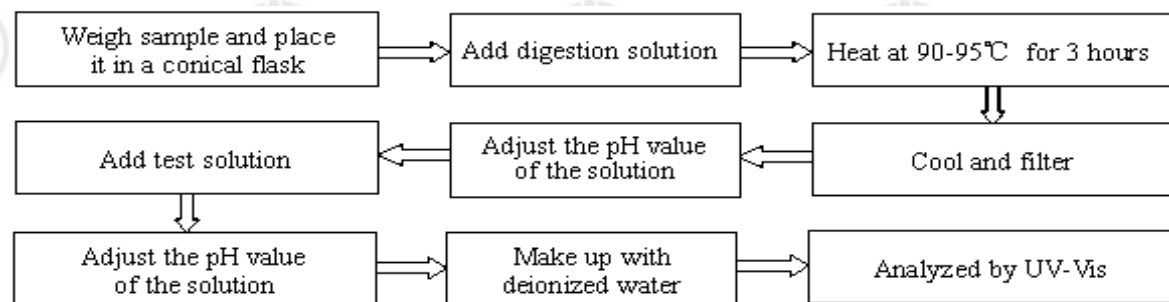
### 1. Lead (Pb), Cadmium (Cd)



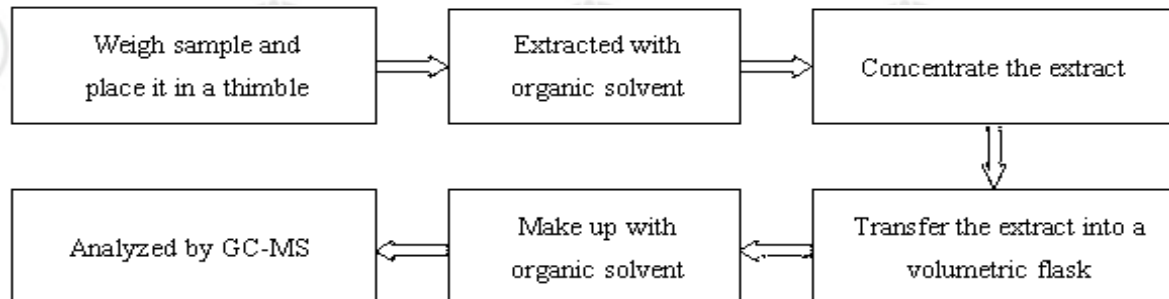
### 2. Mercury (Hg)

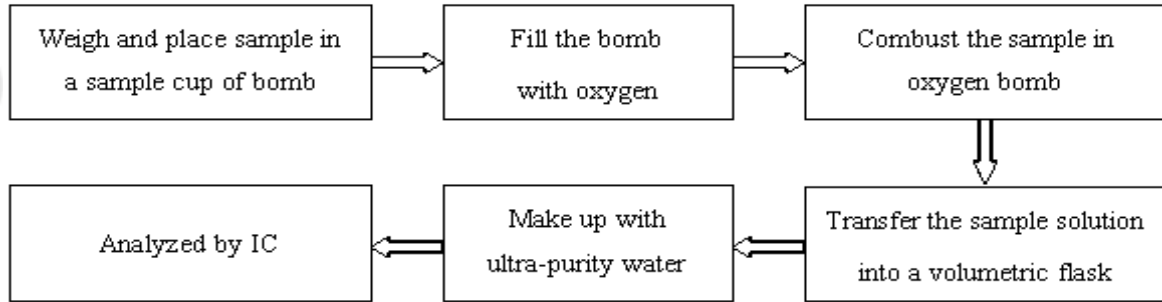

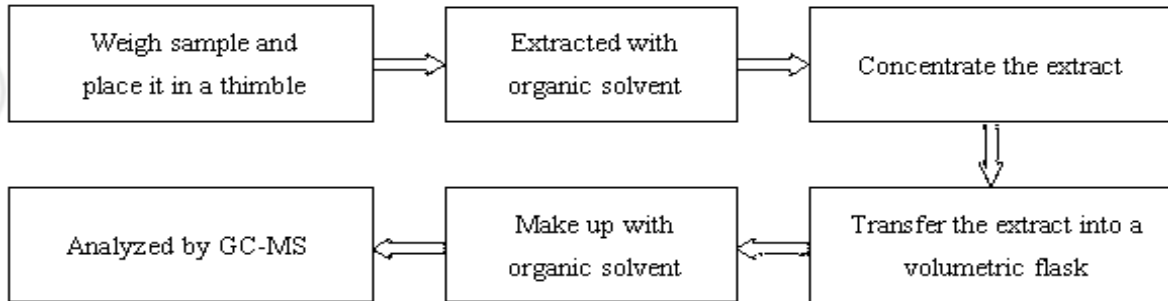

## 6. Phthalates(DBP, BBP, DEHP, DIBP)

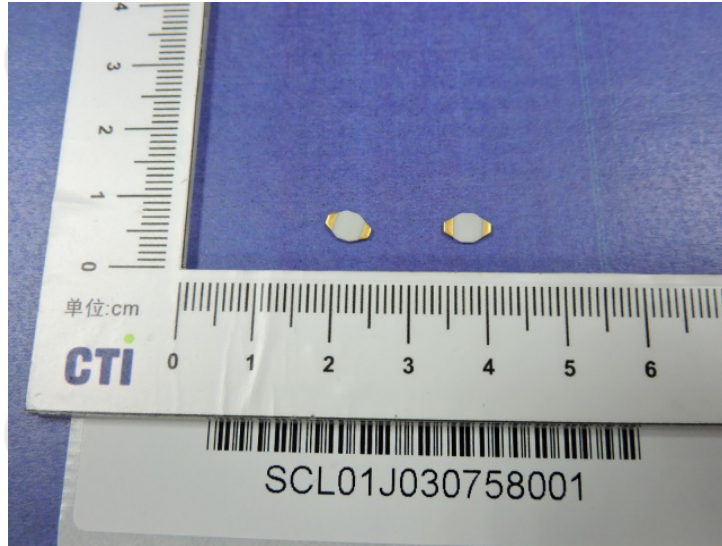
